Good evening Nick et al.,

I appreciate your and your council's thorough and comprehensive response. In sum, I find the response helpful to understand the OEDC's thinking, and I find the edits to the compact reasonable.

We've talked about my concerns around the feasibility of redeveloping the airport: 1) not supported by the Board of Supervisors (on Tuesday the Board voted 5-0 to implement our 5-year Capital Improvement Plan, which includes the airport capital improvements), 2) not supported by the FAA (I've attached their letter), 3) the flood plain presents major challenges which have been underscored by the current AG creek levee situation.

I appreciate you and your council's big picture thinking and don't want to foreclose possibilities. I just think that we have bigger fish to fry and lower hanging fruit to grab as you put it. Let's get to work on those things first. It seems we agree.

In terms of process and next steps, the OAC is working up some suggested revisions to the compact. VACO wanted to schedule another meeting to discuss due to their concerns. Supervisor Ortiz-Legg and I are working on our ad hoc committee to develop recommendations for improving advisory councils county-wide.

After I've made progress on these efforts, let's meet to discuss.

Other updates:

Annexation

I want to loop you and your council in on a very early conversation that is taking place. There is an idea out there that a study should be commissioned to evaluate the potential for Oceano to be annexed by the City of Grover Beach. This discussion was prompted due to Oceano's inability to pay for fire service (the OSCD has initiated LAFCO proceedings to divest from fire service responsibility). The central question is - given its financial problems whether Oceano would be better served receiving city services (police, fire, public works, water/sewer, parks/recreation, and community development) as opposed to the limited services that the Oceano Community Services District and the County are able to provide. Other very important questions include whether it could retain its name and unique identity much like the community of Shell Beach did after it was annexed by the City of Pismo Beach, and whether gaining seats on the Grover Beach City Council would address representation problems that have been underscored by the recent challenges surrounding advisory-only community advisory councils. As the supervisor representing Oceano, I'm certainly not opposed to studying possibilities -- right now, I'm just trying to understand if there is even any interest in studying the possibility with city, county, and CSD representatives. The process would require a number of steps with many decision-makers and many important opportunities for community engagement in the process,
